## **The Role of Rabbi Jesus in the Courts of Heaven.**

As both Judge and Advocate, Jesus grants believers legal standing in the Courts of Heaven. He doesn't simply represent us symbolically—He stands in court with the full weight of divine authority, pleading our case and administering righteous verdicts.



## **Understanding the Heavenly Courtroom**

The Courts of Heaven are not a metaphor—they are a real, structured, legal environment in the spirit realm. Governed by God's righteousness, these courts handle accusations, appeals, and decrees with perfect order



## **Understanding the Heavenly Courtroom**

Every accusation must be addressed legally.  
Emotional or religious responses do not suffice.  
The blood of Jesus, our testimony, and true  
repentance form the defense that silences the  
accuser.



## Key Principles:

Heaven operates under divine justice, not chaos or sentiment.

Satan's accusations are real, but they are answerable through legal processes.

The cross was not just an act of mercy—it was a legal transaction.



## Presenting Cases Before the Judge

In Luke 18, Jesus teaches us through the parable of the persistent widow that prayer is not just communion—it's legal petition. The widow didn't plead based on emotion; she returned to court daily based on her legal right to justice.



## Protocols for Legal Alignment

Legal access to the Courts of Heaven depends on proper alignment. That alignment begins with repentance, humility, and truth. Scripture tells us to “agree with our adversary quickly” because delayed settlement leaves us vulnerable to judgment.


## **Jesus: Advocate, Judge, and High Priest**

Jesus alone occupies every major role in the Heavenly Court. He is your Advocate (1 John 2:1), your Judge (John 5:22), and your eternal High Priest (Hebrews 4:14). He speaks in your defense and pleads your case with the blood that speaks “better things than the blood of Abel.”



## **Jesus: Advocate, Judge, and High Priest**

Every time you step into the Courts of Heaven, Jesus is there—standing for you, presenting your case, and ensuring that your destiny is not forfeited due to accusation or ignorance.



## **Verdicts, Decrees, and Breakthroughs**

When Heaven rules in your favor, that verdict is sealed as a decree. A decree is a legally binding spiritual order that the enemy must obey.

Breakthrough is not a feeling—it's the result of enforced verdicts.




